# Privacy Notice

## 1. Introduction

This Privacy Policy explains how we collect, use, disclose, store, and protect your personal information when you interact with our website and services.

We comply with the [Privacy Act 1988 \(Cth\)](#) and the [Australian Privacy Principles \(APPs\)](#).

By accessing or using this website, you agree to the terms of this Privacy Policy.

## 2. What Personal Information We Collect

We may collect personal information that is reasonably necessary for us to provide our services, operate our business, and comply with legal obligations. This may include:

- Name, contact details, and account information
- Payment and billing information
- Information submitted through contact forms, enquiries, or service requests
- Website usage data, cookies, IP addresses, and browser information

  - Complying with legal or regulatory obligations
  - Sending information, updates, or marketing communications (with opt-out options)

We will not use your information for purposes other than those for which it was collected, unless permitted by law.

## 5. Disclosure of Personal Information

We may disclose personal information to:

- Service providers assisting us with operations, IT, payment processing, marketing, logistics, or analytics
- Professional advisors, auditors, or insurers
- Government authorities where required by law
- Third parties with your consent

We take reasonable steps to ensure third-party recipients comply with the Privacy Act and handle information securely.

Some service providers may be located overseas. If your information is transferred outside Australia, we will take reasonable steps to ensure it is protected in accordance with the Australian Privacy Principles.

## 6. Cookies and Website Tracking

Our website may use cookies, tracking technologies, and analytics tools to improve functionality and measure performance.

Cookies may collect:

- Browser and device information
- Pages visited
- Time and date of visits
- Referring websites

You may adjust your browser settings to refuse cookies; however, this may impact site functionality.

## 7. Data Security

We take reasonable steps to protect your personal information from misuse, interference, loss, and unauthorised access, modification, or disclosure.

Security measures may include:

- Secure servers and encryption
- Access controls and authentication
- Regular monitoring and system updates
